

- 3 Production of originals of AICTE / COA / DGS approval and all other related documents for verification.
- 4 Provisional Affiliation (Conditional): In respect of programmes for which conditional provisional affiliation is granted, re-inspection will be conducted, if the University deems it necessary, to verify the compliance in rectifying the deficiencies already communicated.
- 5 The provisional affiliation is granted without prejudice to the right of the University of requiring production of certificate required under section 37-B of Tamil Nadu Land Reforms (LC) Act 1961 subject to the decision of the Hon'ble High Court of Madras in W.A.No.3454/2002 batch and W.A.No.3482/2002 batch.

- 6 Under no circumstance, fresh admission be made in the above course(s) during the academic year 2009-10, until and unless the continuation of provisional affiliation is obtained from the University.
- 7 The Management should submit a duly signed undertaking on a Rs.20/ non-judicial stamp paper to the Registrar, Anna University, Coimbatore 641 013, within 15 days from the date of receipt of this letter to the effect that the conditions specified above will be fulfilled.
